RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO, CALIFORNIA SETTING A PUBLIC
HEARING TO DETERMINE WHETHER THE PUBLIC
CONVENIENCE AND NECESSITY REQUIRE THE
CONSTRUCTION OF CERTAIN PUBLIC IMPROVEMENTS
IN AN ASSESSMENT DISTRICT.

(ASSESSMENT DISTRICT NO. 4055 [CAMINO DEL RIO SOUTH])

WHEREAS, the City Council is considering the initiation of proceedings pursuant to the Municipal Improvement Act of 1913, being Division 12 of the Streets and Highways Code of the State of California and/or The City of San Diego Improvement District Procedural Ordinance of 1982, as amended, for the formation of an assessment district within a portion of the City designated as Assessment District No. 4055 (Camino Del Rio South), to finance the acquisition or construction of certain street improvements more fully described below;

WHEREAS, the City Council desires to set a public hearing as authorized by Article 16, Section 19 of the Constitution of the State of California prior to initiating formal proceedings to establish the District in order to determine if the public convenience and necessity require such improvements, NOW,
THEREFORE,

BE IT RESOLVED, by the City Council of The City of San Diego, that it does hereby find, resolve, determine and order, as follows:

1. That the foregoing Recitals are true and correct.

2. That the City Council does hereby set a public hearing to be conducted on September 18, 1990 at 2:00 p.m. or as soon thereafter as possible in the City Council Chambers located at 202 "C" Street, San Diego, California, for the purpose of receiving evidence and testimony as to whether the public convenience and necessity require the acquisition or construction or both of the following public improvements within proposed Assessment District No. 4055 [Camino Del Rio South]:

Street improvements to Camino Del Rio South extending from Texas Street to Interstate 805 including grading, paving, curbs, water lines, sewer lines, drainage facilities, fire hydrants, traffic signals at Texas Street and Camino Del Rio South and appurtenances and appurtenant work.


3. That at the time and place set for said public hearing, the City Council shall receive all evidence and testimony from all interested parties as to whether the public convenience and necessity require the acquisition or construction of the improvements described in Section 2 herein above.

4. That the City Clerk is hereby directed to cause notice of this public hearing to be given by publication pursuant to Government Code Section 6061, by posting notice in a conspicuous place where such notice is readily available to the members of the general public and each 300 feet along Camino Del Rio South and by mailing notice to each property owner who the Street Superintendent determines may benefit from and be assessed for

the cost of the acquisition or construction of such public improvements.
