

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$70,000 from Fund 41502, Dept. 700, Org. 281, Acct. 4638, Job Order 181069 (C.I.P. 73-290.0), and not to exceed \$70,000 from Fund 41506, Dept. 700, Org. 109, Acct. 4638, Job Order 171389 (C.I.P. 46-151.0), for the above described acquisition and related costs, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk shall deliver the deed and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
