

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Alanna Grunow, Frederick Liebhardt, Marianne Liebhardt and Fritz Liebhardt, for water main and fire hydrant improvements, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-276315, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost which the City Manager shall deem necessary from time to time to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$77,630.00 from Water Revenue Fund No. 41502, Capital Improvement Program, Annual Allocation for Water Main Replacement (CIP No. 73-083.0), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
