
ADOPTED ON AUG 06 1990

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$167,700.00 from the Waste Management/Litter Control Division, Fund No. 41200, is hereby authorized, solely and exclusively for the purpose of providing funds for the above agreement.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to remit unexpended funds, if any, to the appropriate department on advice of the administering department.
