BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$749,000 from Capital Outlay Other Fund No. 302453, CIP No. 21-834, BALBOA PARK REQUIREMENTS, to CIP No. 21-829, BALBOA PARK BUILDING NO. 1 - RENOVATION.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$71,394 from CIP No. 21-822 (funds previously authorized by Resolution No. R-271588) to CIP No. 21-829, BALBOA PARK BUILDING NO. 1 - RENOVATION.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$42,606 from CIP No. 21-113, BALBOA PARK GENERAL REQUIREMENTS, \$38,935 from Park and Recreation Bonds Fund No. 30725, and \$3,671 from Capital Outlay Other Fund No. 302453, to CIP No. 21-829, BALBOA PARK BUILDING NO. 1 - RENOVATION.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$2,132,704 from CIP No. 21-829, BALBOA PARK BUILDING NO. 1 - RENOVATION, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
