APPROVING MAP OF GOLDEN VILLA  
APARTMENTS.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by John F. Young, Licensed Land Surveyor, entitled "GOLDEN VILLA APARTMENTS being a subdivision of Lots 9 thru 16 inclusive of Block 52, Lots 9 thru 14 inclusive of Block 61, and Lots 15 and 16 of Block 62 of San Diego Property Union, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 314, filed in the Office of the County Recorder of San Diego County, April 9, 1873, together with portions of Pueblo Lot 1140 of the Pueblo Land of San Diego, in the City of San Diego, County of San Diego, State of California, according to the map thereof made by James Pascoe in the year 1870, a copy of which said map was filed November 14, 1921 in the County Recorder's Office of said San Diego County. Together with Gregory Street, Elm Street, and a portion of Felton Street as closed and vacated to public use." is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; and that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress of emergency vehicles and for the construction and maintenance of water and general utility facilities, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the building restricted easements over, upon or across all those portions of Lots 1 and 2, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the open space easements over, upon or across all those portions of Lots 1 and 2, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; together with the easements with the right of ingress and egress of emergency vehicles and for the construction and maintenance of water and general utility facilities, as well as the building restricted and open space easements, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
