WHEREAS, the vacation of the City's interest in unneeded slope easements affecting portions of Sections 29, 30 and 32, Township 14 South, Range 2 West, S.B.M., as more particularly shown on Drawing No. 17274-2-B attached hereto as Exhibit A, has been requested by the affected property owner; and

WHEREAS, the owner wishes to clear title to his land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the herein-described easements have never been used, and are surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 8300 et seq. of the Streets and Highways Code the slope easements, as more particularly shown on the drawing attached hereto, are hereby vacated.

resolution, attested by him under seal, to be recorded in the  
office of the County Recorder.

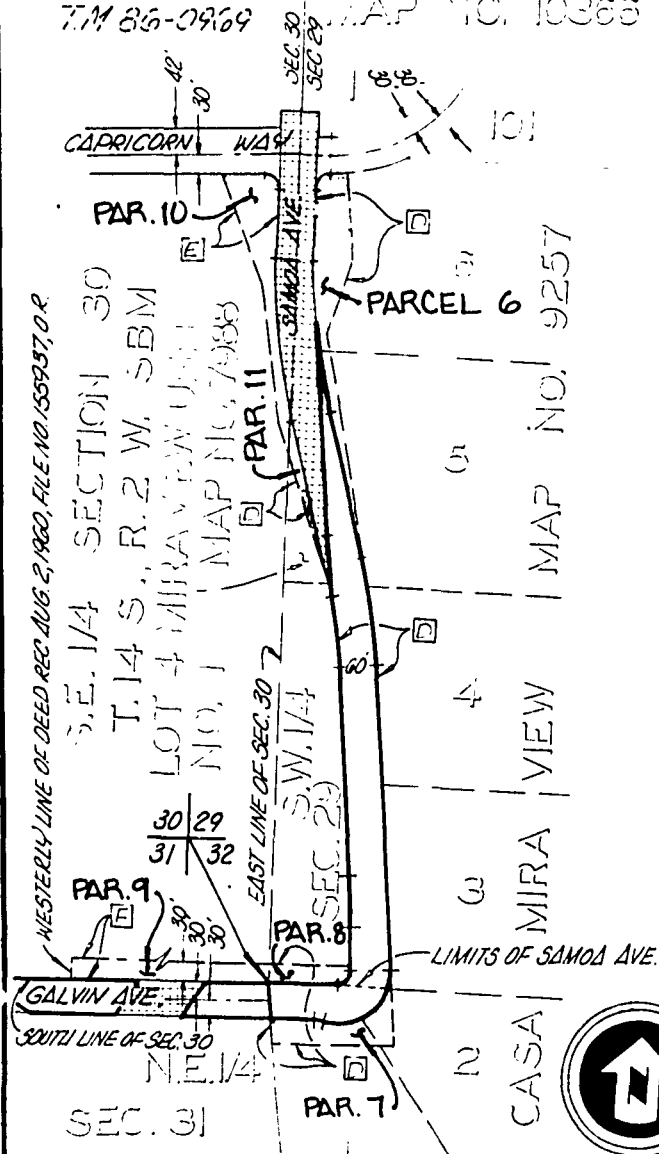
