WHEREAS, DONALD L. BREN COMPANY, a California corporation, has requested an exchange of water, sewer, drainage and building restricted easements; and

WHEREAS, the City will receive water, sewer, drainage and building restricted easements to be granted on proposed Parcel Map W.O. No. 900064; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easements to be acquired will serve the same use and purpose as the easements to be quitclaimed by the City; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Manager and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-276352, quitclaiming to DONALD L. BREN COMPANY, all of the City's right, title and interest in the water, sewer, drainage and building restricted easements in Lots 3, 4, 6 and 7 of Scripps Midlands, Map No. 12441', as more particularly described in the quitclaim deed.

2. That the City Clerk shall cause the quitclaim deed and a certified copy of this resolution, attested by him under seal, to

be recorded in the office of the County Recorder.
