BE IT FURTHER RESOLVED, that the addition of CIP 73-307.0, San Diego Aqueduct Connection No. 5C, to the Fiscal Year 1991 Capital Improvement Program, is hereby authorized.

BE IT FURTHER RESOLVED, that the City Auditor & Comptroller is hereby authorized to transfer an amount not to exceed \$193,000.00 from the Water Unallocated Reserve Fund, No. 41502, to CIP No. 73-307.0, San Diego Aqueduct Connection 5C.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$193,000.00 from CIP No. 73-307.0, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that City forces are authorized to perform the necessary work to construct a raw water pipeline from San Diego Aqueduct Connection No. 5C to the Miramar Reservoir.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
