

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, an addendum to the agreement of December 12, 1988 with Mandeville & Associates, a division of Kleinfelder, for development of a landfill gas control system at the Arizona Street landfill, under the terms and conditions set forth in the Operating Memorandum on file in the office of the City Clerk as Document No. RR- 276367, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost which the City Manager shall deem necessary from time to time to carry out the purpose and intent of the project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$309,370.00 from Refuse Disposal Enterprise Fund CIP No. 37-250.8, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
