

RESOLUTION NUMBER R-276368

ADOPTED ON AUGUST 6, 1990

WHEREAS, San Diego Municipal Code section 67.59 provides that fire service and automatic sprinkler service charges shall be established by resolution of the City Council upon the giving of ten (10) days' notice of intention to establish, amend or increase said charges; and

WHEREAS, pursuant to San Diego Municipal Code section 67.05, the City Manager has recommended that certain monthly fees charged for maintenance and replacement of backflow prevention devices be increased; and

WHEREAS, San Diego Municipal Code section 67.72 provides that minimum water capacity charges may be established by resolution of the City Council upon the giving of ten (10) days' notice of intention to establish, amend or increase said charges; and

WHEREAS, said notice of intention has been given by posting in the office of the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to San Diego Municipal Code section 67.59, the following monthly fire service and automatic fire sprinkler service charges are established:

(A) Effective on the date of passage of this resolution:

That pursuant to San Diego Municipal Code section 67.05, the following maintenance and replacement fees for backflow prevention devices are established:

(A) Effective on the date of passage of this resolution:

(1) \$1.36 per month for each backflow prevention device which is 5/8, 3/4, 1, 1-1/2 or 2 inches in size.

(2) \$2.71 per month for each backflow prevention device which is 3, 4 or 6 inches in size.

(3) \$4.07 per month for each backflow prevention device which is 8, 10 or 12 inches or larger in size.

(B) Effective July 1, 1991:

(1) \$1.44 per month for each backflow prevention device which is 5/8, 3/4, 1, 1-1/2 or 2 inches in size.

(2) \$2.87 per month for each backflow prevention device which is 3, 4 or 6 inches in size.

(3) \$4.31 per month for each backflow prevention device which is 8, 10 or 12 inches or larger in size.

(C) Effective July 1, 1992:

(1) \$1.53 per month for each backflow prevention device which is 5/8, 3/4, 1, 1-1/2 or 2 inches in size.

(2) \$3.04 per month for each backflow prevention device which is 3, 4 or 6 inches in size.

(3) \$4.57 per month for each backflow prevention device which is 8, 10 or 12 inches or larger in size.

(D) Effective July 1, 1993:

(1) \$1.62 per month for each backflow prevention device which is 5/8, 3/4, 1, 1-1/2 or 2 inches in size.

(2) \$3.22 per month for each backflow prevention device which is 3, 4 or 6 inches in size.

(3) \$4.84 per month for each backflow prevention device which is 8, 10 or 12 inches or larger in size.

(E) Effective July 1, 1994:

(1) \$1.72 per month for each backflow prevention device which is 5/8, 3/4, 1, 1-1/2 or 2 inches in size.

(2) \$3.41 per month for each backflow prevention device which is 3, 4 or 6 inches in size.

(3) \$5.13 per month for each backflow prevention device which is 8, 10 or 12 inches or larger in size.

A dual backflow prevention device unit shall be charged a monthly fee one and one-half times that charged for one of the single backflow prevention devices that compose the unit.

That pursuant to San Diego Municipal Code section 67.72, the following minimum water capacity charges are established:

(A) Effective 60 days subsequent to passage of this resolution:

A minimum capacity charge of one thousand nine hundred and sixty dollars (\$1,960) per single family unit or its equivalent shall be paid. This charge shall be subject to simple interest of six percent (6%) from its effective date, to and including that date upon which the charge is paid.

(B) Effective July 1, 1991:

A minimum capacity charge of two thousand three hundred and twenty seven dollars (\$2,327) per single family unit or its equivalent shall be paid. This charge shall be subject to simple interest of six percent (6%) from July 1, 1991, to and including that date upon which the charge is paid.

(C) Effective July 1, 1992:

A minimum capacity charge of two thousand seven hundred and sixty three dollars (\$2,763) per single family unit or its equivalent shall be paid. This charge shall be subject to simple interest of six percent (6%) from July 1, 1992, to and including that date upon which the charge is paid.

(D) Effective July 1, 1993:

A minimum capacity charge of three thousand two hundred and eighty one dollars (\$3,281) per single family unit or its equivalent shall be paid. This charge shall be subject to simple interest of six percent (6%) from July 1, 1993, to and including that date upon which the charge is paid.


(E) Effective July 1, 1994:

A minimum capacity charge of three thousand eight hundred and ninety five dollars (\$3,895) per single family unit or its equivalent shall be paid. This charge shall be subject to simple interest of six percent (6%) from July 1, 1994, to and including that date upon which the charge is paid.

In those areas of the City where a capacity charge in the form of area charges are established by Council resolution, or taxation, or special assessment districts (excluding 1911 and 1913 Act assessment districts), results in a payment to the City totaling more than the aforementioned charge per single family unit or its equivalent, no new capacity charge shall be imposed by this section. However, charges imposed due to reimbursement agreements entered into by the City shall be collected where applicable in every case.

BE IT FURTHER RESOLVED, that this resolution shall be effective and in force on the day of its passage.
