A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING THE CENTRE CITY DEVELOPMENT CORPORATION TO ACT ON BEHALF OF THE CITY FOR THE CONSTRUCTION OF A DAY CENTER FOR THE HOMELESS IN THE CENTRE CITY AREA.

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") is engaged in activities necessary to carry out and implement the redevelopment plans for the Horton Plaza, Marina, Columbia and Gaslamp Quarter Redevelopment Projects; and

WHEREAS, The City of San Diego has determined that Centre City Development Corporation is the appropriate entity to implement construction of a Day Center for the Homeless; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City hereby authorizes the Centre City

 Development Corporation on behalf of the City to receive bids for
 the construction of a Day Center within the Centre City Area
- 2. That the City hereby authorizes the City Manager, or his designee, to award the contract to the lowest qualified bidder provided said bids are within the established budget for the construction of such public improvements
- 3. That the construction contract shall not exceed \$695,000.00, plus up to \$12,500 for contingencies from C.I.P. No. 39-106, Fund No. 19619
 - 4. That the City hereby authorized the Centre City

Development Corporation on behalf of the Agency to administer said contract

5. That the City hereby amends Capital Improvement Program No. 39-106 by increasing the amount \$38,000.00, bringing the total amount to \$880,000.00, and accepts funds in the total amount of \$563,000.00 from the Agency.
