WHEREAS, in 1989, the Foundation's efforts directly impacted more than 20,000 children; and

WHEREAS, on Thursday, September 13, 1990, a "Roller Coaster Rock 'N' Roller" fundraiser to benefit the Foundation will take place at Belmont Park; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby officially declare September 13, 1990, "CHILD ABUSE

PREVENTION FOUNDATION DAY" in honor of the organization's
continued commitment to the youth of San Diego.
