BE IT RESOLVED, by the Council of The City of San Diego that the low bid of \$ 1,919.60 by WALTER H. BARBER & SON, INC., a California corporation, meeting specifications for THE CONSTRUCTION OF STORM DRAINS ON RIVIERA DRIVE FROM EDGE CLIFF DRIVE TO LA CIMA DRIVE, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 119342.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$64,000 from Fund No. 30245, CIP No. 11-247, RIVIERA DRIVE STORM DRAINS, to supplement funds previously authorized by Resolution No. 275596, adopted on April 30, 1990 (in the amount of \$51,000 for a total of \$115,000), is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
