BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. ARENSON OFFICE FURNITURE and 2. EXPRESS COMPUTER SUPPLY, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing FOLDING TABLES AND CHAIRS, STACKING CHAIRS, AND TABLE AND CHAIR DOLLIES as may be required for a period of one (1) year beginning July 1, 1990 through June 30, 1991, per prices on file in the Purchasing Department, as follows:

1. ARENSON OFFICE FURNITURE for Section I - Folding Tables and Section V - Table and Chair Dollies, for a total estimated cost of \$31,028.00; terms net 30 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods with price increases not to exceed 10% of prices in effect at the end of each prior contract period.
2. EXPRESS COMPUTER SUPPLY for Section II - Lightweight Folding Tables; Section III - Folding Chairs, and Section IV - Stacking Chairs, for a total estimated cost of \$38,300.00; terms net 30 days, plus sales tax, with options to renew the contract for four (4) additional one (1) year periods with price increases not to exceed 8% of prices in effect at the end of each prior contract period.
