



BE IT RESOLVED, by the Council of The City of San Diego that the low bid of MACHO TIRE COMPANY, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing APPROXIMATELY 600 STEEL BELTED TIRE CASINGS as may be required for a period of one (1) year beginning October 1, 1990 through September 30, 1991, per prices on file in the Purchasing Department, for a total estimated cost of \$40,800.00; terms net, plus sales tax, with options to renew the contract for three (3) additional one (1) year periods with price escalation not to exceed 5% of prices in effect at the end of each prior contract period.
