KENNEDY, INC. dba KENNEDY'S FOR TIRES, and 5. MACHO TIRE CO., meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing TIRES AND TUBES as may be required for a period of one (1) year beginning September 1, 1990 through August 31, 1991, per prices on file in the Purchasing Department, as follows:

1. DAPPER TIRE COMPANY for Group I - Radial/Tubeless, Passenger Car/Compact Truck, for a total estimated cost of \$51,471.51; terms 1% 30 days, plus sales tax.
2. GENERAL TIRE SERVICE for Group II - Radial, Police High Speed, and Group VI - Miscellaneous Fire Department Truck Tires, for a total estimated cost of \$155,394.00; terms 2% 30 days, plus sales tax.
3. TALIN TIRE INC. for Group III - Radial Bias Tube and Tubeless, Light Trucks and Group V - Bias/Tube, Off Road Tires, for a total estimated cost of \$38,723.45; terms 2% 25 days, plus sales tax.
4. GEO. F. KENNEDY, INC. dba KENNEDY'S FOR TIRES for Group IV - Radial/Bias Tube and Tubeless, Medium/Heavy Duty Truck, for a total estimated cost of \$260,588.68; terms net 30 days, plus sales tax.
