BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. GEORGE F. KENNEDY INC. and 2. TALIN TIRE INC., meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing RECAPPING OF TRUCK TIRES as may be required for a period of one (1) year beginning August 1, 1990 through July 31, 1991, per prices on file in the Purchasing Department, with options to renew contracts for two (2) additional one (1) year periods as follows:

1. GEORGE F. KENNEDY INC. for Sections I, II, IV and V, Medium Duty Truck Tires, Heavy Duty Truck Tires, Recapping - Fire Department; and Refuse Packing Casings; for a total estimated cost of \$206,598.40; terms net 30 days, plus sales tax, with option year increases not to exceed 7% of prices in effect in each prior period.
2. TALIN TIRE INC. for Section III, Off Road, for a total estimated cost of \$6,472.22; terms net 30 days, plus sales tax, with option year increases not to exceed 5% of prices in effect in each prior period.
