PENHALL COMPANY, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the RENTAL OF THREE SPECIFIC TYPES OF OPERATED CONSTRUCTION EQUIPMENT for a period of one (1) year beginning August 1, 1990 through July 31, 1991, per prices on file in the Purchasing Department as follows:

1. BOB'S GRADALL for the primary contract for Item 1; terms 2% 10 days, with options to renew the contract for four (4) additional one (1) year periods, with increases not to exceed 5% of prices in effect in the prior period.
2. RUTLEDGE GRADALLS for the secondary contract for Item 1; terms net, with options to renew the contract for four (4) additional one (1) year periods, with increases not to exceed 6% of the prices in effect in the prior period.
3. SAN DIEGO CONCRETE CUTTING CO., INC. for the primary contract for Item 3; terms net, with options to renew the contract for four (4) additional one (1) year periods, with increases not to exceed 10% of the prices in effect in the prior period.
4. PENHALL COMPANY for the secondary contract for Item 3; terms net, with options to renew the contract for four (4) additional one (1) year periods, with increases not to exceed 6% of the prices in effect in the prior period.
