BE IT RESOLVED, by the Council of The City of San Diego that the sole and low bids of 1. MUSTANG EQUIPMENT CO., 2. ZAGAMI, INC., dba CLAIREMONT EQUIPMENT CO., and 3. HERTZ EQUIPMENT RENTAL, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the RENTAL OF ASPHALT GRINDERS AND MOTOR GRADERS as may be required for a period of one year beginning August 1, 1990 through July 31, 1991, as follows:

1. MUSTANG EQUIPMENT CO., for the primary contract for Item 1 - Asphalt Grinder, at \$800.00 per day, \$2400.00 per week, plus sales tax, plus \$150.00 per move, with terms of net 30 days, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 12%.
2. ZAGAMI, INC. dba CLAIREMONT EQUIPMENT CO., for the primary contract for Item 2 - Motor Grader, at \$325.00 per day, \$1300.00 per week, plus sales tax, plus \$50.00 per move, with terms of net 30 days, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 10%.
3. HERTZ EQUIPMENT RENTAL, for the secondary contract for Item 2, at \$359.00 per day, \$1436.00 per week, plus sales tax, plus \$45.00 per move, plus terms of 2% 20 days, with options to renew the contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect for the previous contract period by more than 7%.
