BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for WESTERN HILLS NEIGHBORHOOD PARK - IMPROVEMENTS, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on SEP 10 1990, and bearing official Document No. WD. 119329, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for WESTERN HILLS NEIGHBORHOOD PARK - IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized, if circumstances warrant, to finance or refinance this project with tax exempt securities.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$4,975 from PSD No. 11420, and \$2,375 from PSD No. 13000 to CIP No. 29-689, WESTERN HILLS NEIGHBORHOOD PARK - IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$35,350 from CIP No. 29-689, WESTERN HILLS NEIGHBORHOOD PARK - IMPROVEMENTS, all PSD Funds, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
