WHEREAS, the Mira Mesa community has benefited from her service as an officer and active member of the Mira Mesa Community Planning Group; and


WHEREAS, Pamela continues to educate and inform her fellow citizens in a variety of public forums and as a reporter for the community newspaper, the Sentinel; and
