WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and


WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW, THEREFORE,

SUGGESTION: Mr. McAfee was a Sanitation Driver II and a Special Collections Field Representative at the time of this suggestion. Mr. Long was a Utility Worker and Mr. Reed was a Sanitation Driver I at the time this suggestion was submitted. They developed a procedure to repair badly damaged concrete litter containers. This procedure resulted in actual savings of \$18,193.70. This is the remainder of their award. It will be divided equally among the three suggesters.
