WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

NAME(S): Norman H. Jones
DEPARTMENT: Managers
AMOUNT: \$50
SUGGESTION: Mr. Jones was a plumber at the Stadium at the time of this suggestion. He suggested that eight below ground hose bibs be capped off to prevent dirt from falling into the water lines. This is considered an operational improvement. A full intangible award is being given.

NAME(S): Charles V. Svenson
DEPARTMENT: Property
AMOUNT: \$50
SUGGESTION: Mr. Svenson was a Property Agent in the Property Management Division of Property at the time of this suggestion. He suggested preparing a brochure for leasees which would explain how the lease accounting system works and the importance of returning invoices even though no rent may be owed at the time. This is a full intangible operational award.



NAME(S): Donna Klimas
DEPARTMENT: City Treasurer
AMOUNT: \$91.94
SUGGESTION: Ms. Klimas was a Senior Cashier in the Treasurer's Department at the time of this suggestion. She suggested that City Departments use plastic bags and some plastic seals for all cash and checks submitted to the bank for deposit. The actual savings realized from this suggestion were \$1,094.42. This is the remainder of her award.

NAME(S): James R. Jarvis
DEPARTMENT: Water Utilities
AMOUNT: \$148.50
SUGGESTION: Mr. Jarvis was a Junior Chemist for the Engineering section of Water Utilities at the time of this suggestion. He suggested that methylene chloride be recycled and used as a rinse solvent. This resulted in a savings of \$495. This is the full award.

NAME(S): Maria M. LeSire
DEPARTMENT: Water Utilities
AMOUNT: \$160
SUGGESTION: Ms. LeSire was a Waste Water Plant Operator at the time of this suggestion. She suggested that the polymer holding tanks at Fiesta Island be marked every hundred gallons so the amount in the tanks can be accurately gaged. This is considered a moderate operational improvement. This is a full intangible award.


NAME(S): Jack A. Salfen
DEPARTMENT: Water Utilities
AMOUNT: \$160
SUGGESTION: Mr. Salfen was a Waste Water Plant Lead Operator in the Metro Division at the time of this suggestion. He suggested that clear PVC pipe be installed on the discharge side of the circulating pumps so that it is possible to know that caustic liquid is being pumped into the caustic scrubber towers. While the original idea was not directly implemented, the concept led to other improvements. This is a full intangible operational award.

NAME(S): Robert H. Abrahamsen
DEPARTMENT: Water Utilities
AMOUNT: \$280
SUGGESTION: Mr. Abrahamsen was a Waste Water Plant Operator in the Metro Division at the time of this suggestion. He suggested that a rubber stamp be used to place a standard format on every page of the daily log book. This insured that all information would be recorded. It eliminated the need to write the same descriptive phrases every day. Actual savings are hard to measure. This is a full intangible operational award.
