RESOLUTION NUMBER R- 276416

ADOPTED ON SEP 10 1990

WHEREAS, on April 2, 1979, the City Council, by Resolution No. 223203, adopted a Conflict of Interest Code for the Housing Commission pursuant to Government Code Section 87307; and

WHEREAS, the code required that Commission members disclose reportable items in a manner substantially equivalent to that of the Political Reform Act and regulations of the Fair Political Practices Commission; and

WHEREAS, on June 9, 1980, the code was amended to include certain designated positions (employees) as well as update provisions affected by amendments to the Government Code and the Political Reform Act; and

WHEREAS, on February 24, 1986, the code was again amended to include by reference the appropriate provisions of the California Administrative Code and any duly adopted amendments thereto; and

WHEREAS, at its meeting of July 18, 1988, the Housing Commission approved an amended Conflict of Interest Code in the form attached, which updates designation of positions (employees) subject to disclosure requirements; and

WHEREAS, a revised Conflict of Interest Code was reviewed and approved by the Rules Committee and is now forwarded to the City Council for approval; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the revised Conflict of Interest Code for the San Diego

Housing Commission, a copy of which is on file in the office of the City Clerk as Document No. RR- 276416, be and the same is hereby approved and adopted.

BE IT FURTHER RESOLVED, that the Conflict of Interest Code for said Commission, adopted by Resolution No. 223203 on April 2, 1979, as amended, be and the same is hereby rescinded.

CONFLICT OF INTEREST CODE FOR
SAN DIEGO HOUSING COMMISSION

The Political Reform Act, Government Code Section 81000, et seq., requires state and local government agencies to adopt and promulgate Conflict of Interest Codes. The Fair Political Practices Commission has adopted a regulation, 2 Cal. Adm. Code Section 18730, which contains the terms of a standard Conflict of Interest Code, which can be incorporated by reference, and which may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act after public notice and hearings. Therefore, the terms of 2 Cal. Adm. Code Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission, along with the attached Appendix in which officials and employees are designated and disclosure categories are set forth, are hereby incorporated by reference and constitute the Conflict of Interest Code of the San Diego Housing Commission.

Pursuant to Section 4(A) of the standard Code, designated employees shall file statements of economic interests with their agencies. Upon receipt of the statements of the Board of Commissioners and Executive Director, the agency shall make and retain a copy of and forward the original of these statements to the Clerk of the City of San Diego. All other originals and copies of statements of designated positions shall be filed with the Secretary of the Board.

APPENDIX A

General Provisions

When a designated employee is required to disclose investments and sources of income, he need only disclose investments in business entities and sources of income which do business in the jurisdiction or have done business in the jurisdiction within the past two years. In addition to other activities, a business entity is doing business within the jurisdiction if it owns real property within the jurisdiction. When a designated employee is required to disclose interests in real property, he need only disclose real property which is located in whole or in part within or not more than two miles outside the boundaries of the jurisdiction or within two miles of any land owned by the local government agency. (The boundaries of the San Diego Housing Commission's jurisdiction are depicted and described on Page A-3.)

Designated employees shall disclose their financial interests pursuant to the appropriate disclosure category as indicated in the Chart on Page A-2.

With respect to Consultants, the Executive Director may determine in writing that a particular consultant is hired to perform a range of duties that are limited in scope and thus not

required to comply with the disclosure requirements described in these categories. Such determination shall include a description of the consultant's duties and, based upon that description, a statement of the extent of disclosure requirements. The Executive Director shall forward a copy of this determination to the Clerk of the City of San Diego. Nothing herein excuses any such consultant from any other provision of this Conflict of Interest Code.
