RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ACCEPTING A BOATING ENFORCEMENT
GRANT FROM THE CALIFORNIA DEPARTMENT OF
BOATING AND WATERWAYS.

WHEREAS, The City of San Diego is desirous of improving its boating safety and law enforcement program; and

WHEREAS, the State of California, Department of Boating and Waterways, has awarded the City a grant for the purchase of a replacement harbor patrol boat; and

WHEREAS, the grant is for an amount up to seventy-five percent (75%) of the purchase price of the boat and attendant equipment, not to exceed thirty-two thousand dollars (\$32,000); and


WHEREAS, the City agrees to the terms and conditions of the grant, the form of which is on file in the office of the City Clerk as Document No. RR- 276433 ; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Council hereby accepts the grant from the California Department of Boating and Waterways.
2. That the City Manager or his representative is hereby authorized and empowered to execute, for and on behalf of said City, all agreements, payment requests and acts required to secure the grant funds.

3. That the City Auditor and Comptroller is hereby authorized to establish as necessary a separate fund for this project which will earn its own interest.
