ADOPTED ON SEP 10 1990

WHEREAS, the Police Department of The City of San Diego desires to continue a parent education project designated Effective Parenting and Youth Responsibility, to be funded in part by funds made available through the Juvenile Justice and Delinquency Prevention Program, administered by the office of Criminal Justice Planning; and

WHEREAS, the grant in each of its first two years provided a total program of \$55,000.00 in supplies and overtime for Juvenile Officers to expand and enhance the parenting component of the existing Juvenile Intervention and Diversion Program; and

WHEREAS, the total third year grant is \$55,000.00 with a required 50 percent (\$27,500.00) in matching funds to be provided by the City from Seized and Forfeited Assets Fund 10132; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to accept continued funding for the Parent Effectiveness project administered by the office of Criminal Justice Planning, as set forth in Resolution No. R-274326 adopted on September 11, 1989, and further authorizing the City Manager to execute the grant award for juvenile diversion and delinquency prevention purposes, including any extensions or amendments thereof and on file in the office of the City Clerk as Document No. RR- 276434, together with any reasonably necessary modifications or


amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project.

BE IT FURTHER RESOLVED, that The City of San Diego shall provide from Seized and Forfeited Assets Fund 10132 all matching funds required during the third year of said project, including any amendments thereof, under the Juvenile Justice and Delinquency Prevention Program and the rules and regulations of the office of Criminal Justice Planning and that funding will be appropriated as required thereby.

BE IT FURTHER RESOLVED, that any grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
