BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a reimbursement agreement with Baldwin Builders, for design and construction of Windwood II and Carmel Grove Mini-Parks, under the terms and conditions set forth in the Reimbursement Agreement on file in the office of the City Clerk as Document No. RR- 276437, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$524,152.64, consisting of \$166,801.12 from CIP 29-627.0, North City West Renaissance Parks-Neighborhood #1, and \$357,351.52 from CIP 29-645.0, North City West Renaissance Parks-Neighborhood #6, North City West FBA Fund No. 79002, is hereby authorized, solely and exclusively to provide funds for the above project.
