
ADOPTED ON SEP 10 1990

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, a reimbursement agreement with Baldwin Builders, for the design and construction of North City West Neighborhood 5 Mini-Park, under the terms and conditions set forth in the Reimbursement Agreement on file in the office of the City Clerk as Document No. RR-276438, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$339,750 from CIP No. 29-713.0, North City West Renaissance Park - Neighborhood #5, North City West FBA Fund No. 79002, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
