

BE IT FURTHER RESOLVED, that the City Auditor & Comptroller is hereby authorized to transfer the amount of \$185,000.00 within the Sewer Revenue Fund (No. 41506), CIP No. 46-086.0, Point Loma Maintenance Building Expansion Project, to the Metropolitan Wastewater Construction Program (No. 70292), Sedimentation Basis 9 and 10 Project, CIP No. 46-088.0.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$250,000.00 from Sewer Revenue Fund No. 41506, CIP No. 46-008.0, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
