

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$13,156.90 from Fund 100, Dept. 110, Org. 485, Account 4682, Job Order 111482, for lease costs from September 1, 1990, to June 30, 1991, be and the same is hereby authorized and approved.
