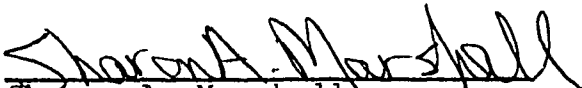

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a third amendment to the agreement with SCRIPPS MEMORIAL MCDONALD CENTER, to continue providing drug and alcohol rehabilitation services for CITYMED HEALTH PLAN, for a one-year period beginning August 1, 1990 through July 31, 1991, a copy of which is on file in the office of the City Clerk as Document No. RR- **276463**, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$65,000 from Fund No. 60021, Account No. 9544, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement.
