ADOPTED ON SEP 10 1990

WHEREAS, San Ysidro has been known internationally as such since the turn of the century and is visited annually by millions of people from the United States, Japan, Europe and Mexico; and

WHEREAS, San Ysidro is an established community proud of its identity as a major port of entry and gateway between the United States and Mexico; and

WHEREAS, there is continued precedent in the San Diego area of communities of unique identity characteristics to retain postal service under the communities' historical names; and

WHEREAS, San Ysidro is physically separated from the City of San Diego core area by the cities of Chula Vista and National City; and

WHEREAS, it is necessary for the economic wellbeing and sustenance of trade that communities maintain a continuity of identity and sustained promotional efforts; and

WHEREAS, there is a repetition of street names between San Diego and San Ysidro; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council endorses the position of the San Ysidro community and the San Ysidro Chamber of Commerce in opposing the changing of the name and zip code of the San Ysidro Post Office.

BE IT FURTHER RESOLVED, that this resolution be transmitted to City governmental offices, informing all departments that the name "San Ysidro, California 92073" be used on all official City correspondence to that area.
