
ADOPTED ON SEPTEMBER 10, 1990

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to develop plans for the improvement of Sorrento Valley Road as a two-lane road to include the correction of any substandard design or potential safety problems that may have been identified during the review process, and to resubmit said project to Council in due course for its consideration and further action.
