
ADOPTED ON SEP 10 1990

WHEREAS, in Closed Session on July 31, 1990, the City Council, by the following vote: Yeas, Districts 2, 3, 4, 5, 6, 7, 8; Nays, Districts 0; Not Present, District 1 and Mayor, approved the following: NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to pay the total sum of One Hundred Ten Thousand Dollars (\$110,000.00) in the settlement of each and every claim against The City of San Diego, its agents and employees, in Superior Court Case No. 606080, Velarde v. City of San Diego, et al. resulting from the personal injuries to Anthony Velarde and Alejandro Jiminez due to an accident which occurred on July 28, 1988.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and is hereby authorized to issue two checks totalling the amount of \$110,000.00, made payable as follows: to Anthony Velarde, the sum of \$85,000.00; and to Alejandro Jiminez, the sum of \$25,000.00, in full settlement of the lawsuit and of all claims.
