APPROVING MAP OF LA JOLLA SHORES
GLEN.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Charles W. Christensen, Registered Civil Engineer, entitled "LA JOLLA SHORES GLEN being a subdivision of a portion of Pueblo Lots 1280 and 1297 of Pueblo Lands of San Diego in the City of San Diego, County of San Diego, State of California, according to map thereof made by James Pascoe in 1870, filed in the Office of the County Recorder of San Diego County, November 14, 1921 and known as Miscellaneous Map No. 36," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map is in substantial conformance with the approved tentative map; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of water and drainage facilities, as granted and shown on the map within the subdivision and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the building restricted easement

over, upon or across all of Lot 1 and a portion of Lot 2, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map; together with the easements with the right of ingress and egress for the construction and maintenance of water and drainage facilities, as well as the building restricted easement, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
