WHEREAS, PUEBLA PACIFIC DEVELOPMENT CORPORATION, a California corporation, has requested an exchange of drainage easements in a portion of Pueblo Lot 1280; and

WHEREAS, a drainage easement of approximately equal value is being granted on the final map of La Jolla Shores Glen subdivision; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and


WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Manager, or an assistant or deputy City Manager, is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 276530, quitclaiming to PUEBLA PACIFIC DEVELOPMENT CORPORATION, all of the City's right, title and interest in the drainage easement in a portion of Pueblo Lot 1280, as more particularly described in the quitclaim deed.

2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
