ADOPTED ON SEPTEMBER 18, 1990


BE IT RESOLVED, by the Council of The City of San Diego, that the Council has reviewed and approved, and hereby directs the City's representative to SANDAG to support adoption of the Comprehensive Land Use Plan for NAS Miramar, taking into consideration the prior decisions of the City Council that may modify the CLUP.

BE IT FURTHER RESOLVED, that the Council hereby directs the City Manager and the Planning Director to prepare revisions to the Noise Abatement and Control Ordinance (Municipal Code section 59.5.0701) and those community plans affected by NAS Miramar's noise contours or accident potential zones to implement the recommendations of the Comprehensive Land Use Plan for NAS Miramar.

BE IT FURTHER RESOLVED, that the City Council hereby reaffirms its position with respect to having NAS Miramar remain strictly a military airport.
