RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, APPROVING AND AUTHORIZING EXECUTION OF CERTAIN AGREEMENTS IN A SPECIAL ASSESSMENT DISTRICT.

(Assessment District No. 4025 [Mission Valley Heights])

WHEREAS, the City Council of The City of San Diego,

Division 12 of the Streets and Highways Code of the State of

an Acquisition/Financing Agreement setting forth certain terms and conditions as well as estimated prices and quantities of work to be installed and financed pursuant to the said Agreement, and Assignment Agreements with various utility companies; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the above recitals are all true and correct.
- 2. That the Amended Agreement for Assessment Engineering Services in an amount not to exceed \$9,500.00 submitted herewith, Document No. D2273-14, by and between the City and BSI Consultants, Inc., is hereby approved, and the City Manager is hereby authorized to execute said Agreement on behalf of the City.
- 3. That the Assignment Agreement, as submitted herewith, Document No. D2273-15 by and between the City, Pacific Bell and H.G. Fenton Material Company, is hereby approved, and the City Manager is hereby authorized to execute said Agreement on behalf of the City.
- 4. That the Assignment Agreement, as submitted herewith, Document No. 2273-16 by and between the City, San Diego Gas & Electric Company and H.G. Fenton Material Company, is hereby

approved, and the City Manager is hereby authorized to execute said Agreement on behalf of the City.
