RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, MAKING A DETERMINATION THAT THE PUBLIC CONVENIENCE AND NECESSITY REQUIRE THE ACQUISITION OR CONSTRUCTION OF CERTAIN PUBLIC IMPROVEMENTS IN AN ASSESSMENT DISTRICT.

(Assessment District No. 4055 [Camino Del Rio South])

WHEREAS, the Council of The City of San Diego is considering the initiation of proceedings pursuant to the Municipal Improvement Act of 1913, being Division 12 of the Streets and Highways Code of the State of California and/or City of San Diego Improvement District Procedural Ordinance of 1982, as amended, for the formation of an assessment district within a portion of the City designated as ASSESSMENT DISTRICT NO. 4055 [CAMINO DEL RIO SOUTH] to finance the acquisition or construction of certain street improvement more fully described herein below; and

WHEREAS, on September 18, 1990, the City Council conducted a public hearing as authorized by Article 16, Section 19 of the Constitution of the State of California in order to determine if the public convenience and necessity require the acquisition or construction of such public improvements; and

WHEREAS, at such public hearing, the City Council did receive all evidence and testimony of all interested persons;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the foregoing recitals are true and correct.

2. That based upon the evidence and testimony and staff report presented at the public hearing conducted September 18, 1990, the Council hereby makes the findings as set forth in Exhibit A attached hereto and incorporated herein by this reference.

3. That based upon the evidence, testimony and staff report provided at the September 18, 1990 public hearing and the findings set forth in Exhibit A, the Council hereby determines that the public convenience and necessity require the acquisition or construction or both of the following public improvements within proposed Assessment District No. 4055 (Camino Del Rio South):


Street Improvements to Camino Del Rio South extending from Texas Street to Interstate 805 including grading, paving, curbs, water lines, sewer lines, drainage facilities, fire hydrants, traffic signals at Texas Street and Camino Del Rio South and appurtenances and appurtenant work.

4. That the City Manager is hereby directed to take or cause to be taken all action deemed necessary to initiate the proceedings to form Assessment District No. 4055 [Camino Del Rio South] pursuant to the Municipal Improvement Act of 1913, being Division 12 of the Streets and Highways Code of the State of

EXHIBIT A

FINDINGS OF THE CITY COUNCIL

1. Camino Del Rio South from Texas Street to I-805 is currently constructed as a two-lane road.

2. The current two-lane figuration of this portion of Camino Del Rio South has a design capacity for a maximum average daily traffic (ADT) count of 7500 vehicles. The current ADT for this portion of Camino Del Rio South is approximately 13,500 vehicles, 6,000 vehicles over the design limit.

3. The proposal that this portion of Camino Del Rio South be constructed as a four-lane collector which will provide for a maximum ADT of 15,000 thereby eliminating the existing congestion and corresponding traffic safety concerns.
