BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those deeds of ADCOR REALTY CORPORATION, a New York corporation, of TEACHERS INSURANCE AND ANNUITY ASSOCIATION OF AMERICA, a New York corporation, and of GUARANTY SERVICE CORPORATION, a Texas corporation, all executed in favor of The City of San Diego, bearing dates of April 25, 1990, April 6, 1990, and June 8, 1990, respectively, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR- 276591-1, RR- 276591-2 and RR- 276591-3, granting to said City easements for pedestrian and non-motor vehicle purposes in Parcel 3 of Parcel Map No. 6481, in Parcel 1 of Parcel Map No. 12903, and in Lot 12 of Costa Verde, Map No. 12045, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for pedestrian and non-motor vehicle right-of-way.


