
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an amendment to the agreement of May 15, 1989 with Fraser Engineering, Inc., for consultant services in connection with the restoration of Sewer Pump Stations 17 and 27, under the terms and conditions set forth in Amendment No. 1 on file in the office of the City Clerk as Document No. RR- 276598.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$70,989.00 from the Sewer Revenue Fund, No. 41506, CIP No. 46-106.0, Annual Allocation for Pump Station Restorations, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
