
ADOPTED ON SEP 24 1990

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a ten-year lease agreement with Ocean Beach Child Care Project, Inc., to provide child care services for low income families in the Ocean Beach community, at 2031 and 2041 Chatsworth Boulevard, San Diego, at a rental of \$1.00 for the term.

BE IT FURTHER RESOLVED, that the Council acknowledges the fact that the insurance policy obtained by Ocean Beach Child Care Project, Inc. excludes risks associated with child abuse and child molestation since such coverage is not presently available in the insurance market.
