BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, agreements with Normal Heights Community Development Corporation and City Heights Community Development Corporation, for specified economic development activities, under the terms and conditions set forth in the Agreements on file in the office of the City Clerk as Documents No. RR- 276600 -1 and RR- 276600 -2, together with reasonably necessary modifications or amendments thereto which do not increase projects scope or cost and which the City Manager shall deem necessary from time to time to carry out the purposes and intent of the projects and agreements

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$277,100.00, consisting of \$85,000.00 for Normal Heights Community Development Corporation from Fund 18526, Department 5896, Organization 9605, and \$192,100.00 for City Heights Community Development Corporation from Fund 18526, Department 5895, Organization 9501, is hereby authorized, solely and exclusively for the purpose of providing funds for the above projects.
