RESOLUTION NUMBER R- 276602

ADOPTED ON SEP 24 1990

WHEREAS, AFFINITY LIMITED, a California limited partnership, has requested an exchange of water and drainage easements in Lots 8, 15 and 16 of Scripps Midlands, Map 12441; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easements to be acquired will serve the same use and purpose as the easements to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of AFFINITY LIMITED, executed in favor of The City of San Diego, bearing date of March 16, 1990, conveying to said City water and drainage easements in Lots 8, 15 and 16 of Scripps Midlands, Map 12441, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 276602-1, is hereby approved.

2. That the City Manager or his designee be, and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 276602-2, quitclaiming to AFFINITY LIMITED, all of the City's right, title and interest in the water and drainage easements in Lots 8, 15 and 16 of Scripps Midlands, Map 12441, as more particularly

described in the quitclaim deed.

3. That the City Clerk shall cause both deeds, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder, the easement deed recorded at no fee, for the benefit of the City, with no documentary tax due.
