
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Motorola Communications and Electronics, Inc., for the provision of a public safety 800 MHz radio/dispatch console system, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 276605, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost which the City Manager shall deem necessary from time to time to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$16,732,784.00 from CIP No. 33-495, Public Safety Communications Project, is hereby authorized, solely and exclusively to provide funds for this project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance all or parts of this project with General Obligation Bonds, if circumstances warrant.
