That the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a Cancellation of Escrow Instructions, dated September 7, 1990, which document cancels the original Escrow No. 969421, a copy of which Cancellation of Escrow Instructions is on file in the office of the City Clerk as Document No. RR-
- 3. That the City Manager is hereby authorized to accept, for and on behalf of The City of San Diego, a Grant Deed of TLS INVESTORS, a California limited partnership, executed in favor of The City of San Diego, conveying to the City the Famosa Slough, being a vacant parcel of land consisting of approximately 20.45+ acres, being a portion of Pueblo Lot 211 of Pueblo Lands of San

Diego, Miscellaneous Map 36, and a portion of Block D of Loma Alta 2, Map No. 1082, a copy of which deed is on file in the office of the City Clerk as Document No. RR-276666-3.

4. That the expenditure of additional funds not to exceed \$1,121,000, consisting of \$500,000 from Capital Outlay Fund 38004 (Environmental License Plate Fund Grant), and \$621,000 from Wetland Acquisition Funds 10545 and 105451, to supplement \$2,620,000 in funds previously authorized for property and related costs for the acquisition of Famosa Slough, is hereby authorized and approved.
