WHEREAS, Wells Fargo Bank NA ("Wells Fargo") and Great American First Savings Bank ("Great American") have announced the proposed acquisition of certain Great American's assets and branches by Wells Fargo; and

WHEREAS, Wells Fargo and Great American have applied to the Office of the United States Comptroller of the Currency for permission to consummate this acquisition; and

WHEREAS, pursuant to the Code of Federal Regulations the public comment period to the Office of the United States Comptroller concerning this proposed acquisition is scheduled to end on September 29, 1990; and


WHEREAS, the City's Public Service and Safety Committee has scheduled and held a public hearing on this proposed acquisition on September 19, 1990, following which the Committee will make certain recommendations regarding formal comments to be submitted to the United States Comptroller; and

WHEREAS, it would appear that an extension of time for public comment to the United States Comptroller is necessary and desirable in order for City Council action on the Committee's recommendation to be taken; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that, pursuant to the provisions of the Code of Federal Regulations, the United States Comptroller of the Currency and his designated representatives be and they are hereby requested

to extend the public comment period concerning this proposed acquisition for an additional thirty (30) days in order to allow this City Council to duly act, consider and take such action as is appropriate regarding the Committee's recommendations and forward its determination to the United States Comptroller and his representatives.
