
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to accept, for and on behalf of said City, a grant from the Federal Aviation Administration, for the Brown Field runway rehabilitation in the amount of \$307,800.00.

BE IT FURTHER RESOLVED, that the Fiscal Year 1991 Capital Improvement Program is hereby modified by adding CIP 31-159.0, Brown Field - Runway Rehabilitation.

BE IT FURTHER RESOLVED, that the City Auditor & Comptroller is authorized to transfer the amount of \$34,200 from Annual Allocation CIP 31-001.0 to CIP 31-159.0.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$34,200.00 in matching funds from Fund No. 10511, CIP 31-159.0, is hereby authorized, solely and exclusively for the purpose of providing matching funds for the above project.
