BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for SEWER PUMP STATION NO. 10, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on OCT 01 1990, and bearing official Document No. W.O. 171291, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for SEWER PUMP STATION NO. 10.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with JAYKIM ENGINEERS, INC., for additional engineering design and construction services at a cost not to exceed \$69,009, in connection with SEWER PUMP STATION NO. 10, and a portion of MISSION BAY SEWAGE INTERCEPTOR SYSTEM, under the terms and conditions set forth in the agreement on file in the Office of the City Clerk as Document No. RR-272771.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$2,028,182 from Sewer Revenue Fund No. 41506, CIP No. 46-106.0, ANNUAL ALLOCATION FOR PUMP STATION RESTORATIONS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
